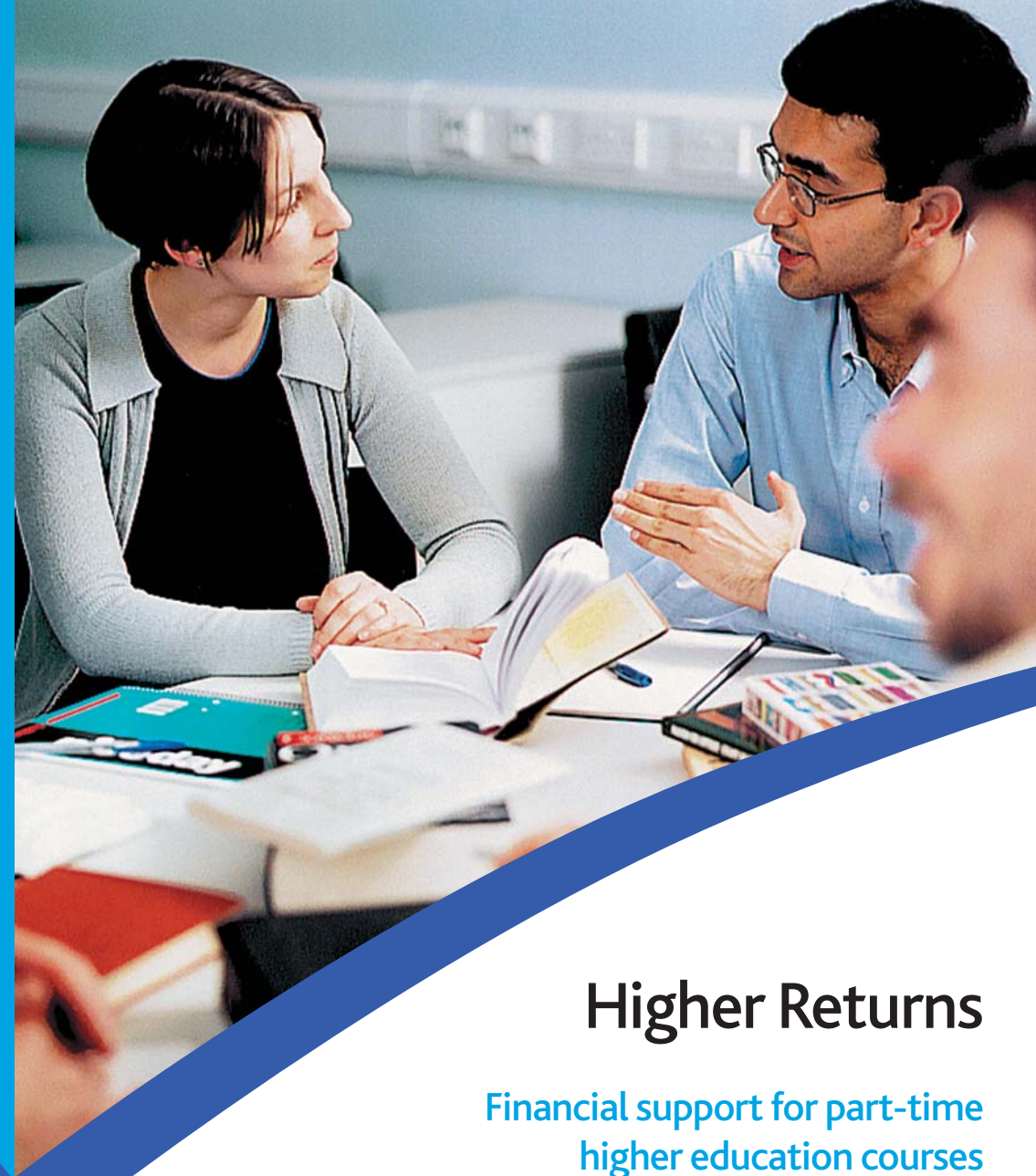

Did you know that financial support is available from the Government for employees who study for part-time higher education (HE) courses?

Part-time education provides your employees with the opportunity to enhance their professional and workplace skills enabling your business to gain a competitive advantage. Read on to find out how to access the Government funding available.

What financial support is available?

- A **fee grant** of up to **£1,150** a year (towards tuition fees). This is non-repayable and paid direct to the education institution.
- A **course grant** of up to **£250** a year (towards books, materials, travel expenses and other course costs). This is non-repayable and paid direct into the employee's bank account in one lump sum.
- Extra financial help may also be available for eligible employees.

The fee and course grants depend on the employee's income and if the employee has a partner and/or children. The maximum fee grant available depends on the intensity of the course.*

Intensity of course (rate of study)	Maximum fee grant	Maximum course grant	Total maximum support
75% or more full-time course intensity	Up to £1,150 a year	£250	£1,400
60% to 74% full-time course intensity	Up to £920 a year	£250	£1,170
50% to 59% full-time course intensity	Up to £765 a year	£250	£1,015

Study

Examples of financial support available:

An eligible employee who is single (i.e. an employee without a partner or dependants) could be entitled to:	
Income (including London Weighting allowance)	Entitlement
below £15,700	the full fee and course grants
between £15,700 - £23,680	a partial fee grant (minimum £50), the full course grant of £250
between £23,681 - £24,279	no fee grant, the full course grant of £250
between £24,280 - £26,180	no fee grant, a partial course grant (minimum £50)
£26,181 and over	no fee or course grants

An eligible employee who is married, has a civil partner, or is living with a partner (of either gender) with:
- no dependent children with a joint income up to £28,180 could be entitled to a partial grant
- two dependent children with a joint income up to £31,180 could be entitled to a partial grant

Who's eligible?

- Employees must be studying for a part-time HE course at a publicly funded UK education institution.
- Employees must be studying at a rate equal to 50% or more of an equivalent full-time course (so employees must be able to complete the course in no more than twice the time it would take to complete the equivalent full-time course). The course must last for at least one year.
- Employees who already have a degree cannot usually apply for fee or course grants.
- Employees are not entitled to fee or course grants for more than one part-time course at a time.
- Employees can be new students or continuing their studies.
- There is no age limit.
- Eligibility is not dependent on employment status.
